### Program overview and objectives

The 2018 Appalachian Structural Heart Symposium (ASHS | 18) conference will provide a comprehensive review of current topics, treatments, and strategies for Structural Heart Disease including: transcatheter aortic valve replacement (TAVR), cardiogenic shock, imaging techniques, medications, case presentations, and poster sessions. This interdisciplinary conference is designed for physicians, pharmacists, nurses, radiologic technicians and technologists, and all interested allied health professionals. On Saturday afternoon there will be concurrent breakout sessions; one for physicians and a simultaneous program for nurses and radiologic technologists and technologists and technologists.

- Enumerate techniques to manage complications of clips
  and closures
- Describe medical management strategies for SHD
