Program overview

This one day conference will review stroke care concepts for the Stroke RN Certification Exam. Target audience for this conference is the registered nurse desiring to take the Stroke certification exam or anyone interested in enhancing their stroke assessment and treatment skills.





Objectives

Anatomy & Physiology:

- Identify basic brain structures and identify difference between arterial and venous anatomy
- Understand stroke physiology at the cellular level
- Define different stroke syndromes, including SAH, ICH and AIS
- Identify common, and uncommon, stroke mimic

Hyper Acute Phase:

- Describe steps and management of initial triage of pre-hospital personnel
- Explain different stroke scales and utilization
- Describe care and management of ischemic stroke patient including administration of thrombolytics and advanced interventions

Acute Phase:

- Identify and implement management of the acute stroke patient including ischemic, ICH and SAH
- Identify common and uncommon etiologies of stroke syndromes

Post-Acute Stroke Care:

- Understand the different roles within the multidisciplinary team
- Understand specialized rehabilitation treatment modalities

Stroke Systems of Care:

- Understand the rationale for use of protocols and pathways and be able to describe foundation of protocols.

Preventative Care:

- Review role of SCRNs in community and prehospital stroke educational outreach
