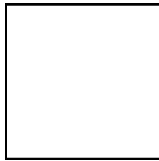

SPEAKER BIOGRAPHIES

Michael Brumage, M.D.

Dr. Michael Brumage is the Assistant Dean for Public Health Practice and Service in the WVU School of Public Health and an Assistant Clinical Professor of Medicine in the WVU School of Medicine as well as Executive Director of the Kanawha-Charleston Health Department and Health Officer for Kanawha County and Putnam County, West Virginia. He received a Bachelor of Science degree in Chemistry (cum Laude) from West Virginia University (WVU) in 1982 and graduated from the WVU School of Medicine in 1986. He received his Master of Public Health in Epidemiology from the University of Washington in 2003. He is board certified in Internal Medicine and Preventive Medicine and is a Fellow of the American College of Physicians. He is also co-Chairman for the West Virginia Adverse Childhood Experiences (ACEs) Coalition. Dr. Brumage retired as a Colonel from the United States Army in 2015 after 25 years of service as an internal medicine physician and later as a public health physician. He deployed twice to the Balkans and from 2004-2005 to Tikrit, Iraq with the First Infantry Division as the Division Surgeon, the equivalent of chief medical officer. He holds three Legion of Merit medals and a Bronze Star, among other awards, from his service.

Christi L. Cooper-Lehki, D.O.

Dr. Cooper-Lehki is a Forensic, Child and Adolescent Psychiatrist and Assistant Professor of Behavioral Medicine & Psychiatry at West Virginia University Hospitals, Chestnut Ridge Center in Morgantown, WV. She is an honors graduate of the West Virginia School of Osteopathic Medicine, 1994. She completed a Child and Adolescent Psychiatry Fellowship at Wayne State University in 2001 and Forensic Psychiatry Fellowship at the West Virginia University School of Medicine in 2005. She is board certified in Psychiatry, Child and Adolescent Psychiatry and Forensic Psychiatry by the American Board of Psychiatry and Neurology and has more than 21 years of diverse experiences in Psychiatry.

Kathleen Martin, M.D.

Dr. Martin received her undergraduate degree from Concord College and completed her doctorate degree at West Virginia University School of Medicine in 2005. She completed her residency in pediatrics at the West Virginia University Charleston Division in 2008. She is currently an assistant professor of pediatrics at the West Virginia School of Osteopathic Medicine and a pediatrician at the Robert C. Byrd Clinic and Greenbrier Valley Medical Center.

Jill Cochran, Ph.D., RN-BC, FNP

Dr. Jill Cochran has been involved in rural health for 35 years. After obtaining her Masters Degree in Nursing, she practiced in small rural West Virginia clinics in Meadow Bridge, Rainelle, Rupert and later in Lewisburg. She is a visiting lecturer for West Virginia School of Dentistry and has been involved in educating health science students in Appalachian values and health care. She completed her doctoral studies in 2011 at West Virginia University and conducted research in children's obesity. She completed a fellowship with the National Rural Health Association in 2009 and has continued as an advocate for rural health. She is presently Assistant Professor at West Virginia School of Osteopathic Medicine and has been a family nurse practitioner in pediatrics at Robert C. Byrd Clinic for 11 years.
